**PAWN BROKERS' (AMENDMENT) STATUTE NO. 01 OF 2015 OF THE CENTRAL PROVINCE
PROVINCIAL COUNCIL**

A Statute for making amendments in the Central Province Provincial Council Pawn Brokers' Statute No. 04 of 2014.

Be it passed by the Provincial Council of the Central Province of the Democratic Socialist Republic of Sri Lanka as follows :

1. This Statute is defined as Central Province Provincial Council Pawn Brokers' (Amended) Statute No. 01 of 2015 and shall be effective from the date approved by the Governor of Central Province. Short title and date of operation
2. Pawn Brokers' Statute No. 04 of 2014 of Central Provincial Council (hereafter defined as Main Statute) versions mentioned in (b), Sub section (1) of Section 8 in the Pawn Brokers Statute (hereafter defined as Main Statute and Shall be substitute new versions mentioned below)



b) A document prepared according to Section 46(1) of this Statute

3. The 3rd Sub Section of Section 10 of the Main Statute is hereby amended as follows.

(3) Security deposits amount or amounts payable by a licence as intimated to licence holder by the Commissioner of Revenue should be deposited to the Commissioner of Provincial Revenue. Amount in deposit thereon shall not be refunded to the depositor except on closure or conveyance of business. However, if there is any amount payable to a pawnor or pawnors of articles by the licensee, such amount shall be deducted from the security deposits.

4. The Section 13 of the Main Statute is hereby amended as follows :

13. The Commissioner of Revenue shall be annually published in the Government *Gazette*, a notice containing,

(1) Name of licenced pawnbroker, name of the business and the address of the premises where the business is carried on

(2) Every occasion when convicted under Section 39 such person's name, private address, name of business and the address where the business was carried out and if the period of validity of a licence has expired and a licence for the following year is not issued.

5. The Sub Section (3) of Section 28 of the Main Statute is hereby amended as follows :

(3) Where as person ceases to carry on the business as a pawnbroker the amount of security furnished by him/her (person) and thereon shall be payable to such pawnbroker, after deducting any amount due for payment of any sum mentioned under Sub section (1)
